### **A note about using the Finding Aid:**

Microform publications are listed in alphabetical order in the Finding Aid with the cabinet location and specific drawer shown next to each title. For example, the listing for the **ABA Journal** has **40(a)** as its location. This identifier indicates that the fiche is located in cabinet number **40**, drawer letter **a**. Next to some titles there are locations that have a number and *two* letter designations: one in bold, upper case indicating the cabinet; the other bracketed in lower case to indicate the drawer. For example, the location for the **American Bar Association Archive Publications** is **26B(g)-28(b)**, which means the fiche can be found in cabinet **26B**, drawer **a** through cabinet **28**, drawer **b**. Cabinets 1 through 5 (against the right-hand wall) have both an overcabinet, designated as drawers **a-e**, and an undercabinet, designated as drawers **f-o**.
