

indidates should have law practice experience and a demonstrated commitment to and competence in legal scholarship. Past successful civil clinical law teaching and administrative experience is highly desirable.

It is expected that the person who fills this position will be appointed as an assistant or associate professor eligible for tenure and promotion pursuant to the rules and procedures generally applicable to the law faculty. It is also expected that -- as is ordinarily the case with other tenure-track faculty members -- employment will be on a nine-month academic-year basis with the opportunity to secure summer stipends to facilitate legal research and writing.

This is a start-up situation. No formal civil clinic now operates at the University of Georgia School of Law. In the near-term, it is expected that this position principally will involve supervision of students in external placements, with no (or very limited) direct responsibility for representing clients. The newly created clinical program may also continue some or all of the work of the school's existing Public Interest Project class. As part of this class, students engage in such activities as representing battered women in proceedings

temporary protective orders, pursuing conternative dispute resolution on behalf of juvenile offenders, and otherwise intervening (often by working through the local homeless shelter, soup kitchen, magistrate's court, etc.) on behalf of persons in need, typically in a non-litigation context.

While future program direction and job duties will depend on such matters as student interest and the availability of resources, this position will provide the opportunity to help build a new civil clinical program.
