Research Assistant Professor of Legal Writing

The University of Arkansas School of Law(Fayetteville) invites applications for the position of Research Assistant Professor of Legal Writing within its Legal Research and Writing program, beginning in the 1999-2000 academic year.

The LRW faculty consists of five full-time teachers. Faculty typically teach two courses each semester. They teach Legal Research and Writing I (3 credits) in the fall and Legal Research and Writing II (2 credits) in the spring to one section of 25-30 first year students. They also teach Legal Research and Writing III (2 credits) to a class of up to 15 second year students each semester. LRW I focuses on analysis

and objective writing; LRW II on appellate brief writing and oral advocacy, including a moot court component. Sections in the past have been matched with a small section of Contracts to allow for collaboration. LRW III is a required second year course which includes drafting client letters, pleadings, a nonlitigation document and a trial level memorandum. Legal Research and Writing Faculty agree on certain programmatic matters, including numbers of assignments and deadlines, but each teacher retains substantial discretion in structuring and teaching the courses.

Appointment is for a nine month term (August - May) which is renewable, with no cap on the length of Salary range service. begins in the mid-30's, depending upon experience. Faculty may have the option of teaching during the summer for additional compensation. Faculty participate on Faculty Committees and several serve as moot court coaches. Support is available for professional development.

Fayetteville is in Northwest Arkansas, approximately 30 miles from both the Missouri and Oklahoma borders, and the site of the main campus of the University. It is a hilly city of approximately 52,000 in the Boston Mountains, foothills of the Ozarks. It has a relatively low cost of living, and a mild climate.
