THE UNIVERSITY OF ALABAMA SCHOOL OF LAW -- VISITING SCHOLARS -- 1995-1997

Don C. Peters -- John S. Stone Chairholder of Law. Professor Peters will visit The University of Alabama in Spring 1997, teaching a Family Law Clinic and Alternative Dispute Resolution. He has been a member of the Faculty at the University of Florida School of Law since 1973 and received the Teaching Excellence and Innovation Award. He is a well known clinical professor and

directs the Virgil Hawkins Civil Clinic with various teaching assignments. Professor Peters received the Senior Fulbright-Hays Award to serve as a visiting professor at the University of Malaya. He also has been a visiting professor at Manash Law School in Melbourne, Australia, and the University of Colorado. Professor Peters has authored numerous publications. He received his law degree from the University of Iowa, where he was a law review editor and was elected to Order of the Coif.



Roy T. Stuckey -- Tom Bevill Chairholder of Law. Professor Roy Stuckey visited The University of Alabama during Spring 1996. He taught Legal Ethics and a Family Law Clinic. He is the Alumni Professional Skills Professor of Law at The University of South Carolina and is highly regarded nationwide for his knowledge of and expertise in clinical education and skills training. prominent and active in the ABA, serving on accreditation teams and as chairperson of the ABA Section of Legal Education and Admissions. He also has been active with the AALS, serving as chairperson of the AALS section on clinical legal education. Professor Stuckey has been associated with The University of South Carolina's clinical program since 1973. PROJECTS

HISTORY/ARCHIVE PROJECT -- J.P. "Sandy" Ogilvy (Catholic University)

At its meeting in May at the 1996 Conference on Clinical Legal Education, the Executive Committee of the Section gave approval to a proposal to create a position of historian/archivist for the Section. Since he made the proposal, the Executive Committee asked Sandy Ogilvy to serve in that role for this year.

Sandy will compile records and collect documents that reflect the work and history of the AALS Section on Clinical Legal Education. For instance, he will attempt to collect a complete set of Section Newsletters and compile an accurate list of Section chairs and committee chairs since the Section was created. He will also collect information about AALS activities primarily directed at clinical faculty, such as information about the annual teaching conferences and workshops and membership on the AALS Committee on Clinical Legal Education.

Everyone should feel free to send Sandy materials that you believe deserve to be archived for the Section as well as suggestions for the type of information and documents that should be kept even if you do not have any documents to contribute at this time.

Sandy has a copy of each issue of the Section Newsletter beginning with March 1984. If anyone has earlier issues, please send him a clean copy.

Sandy has compiled lists of Section Chairs, Committee Chairs and Section Award winners. Except for the Award recipients, the other lists are incomplete. For instance, he has incomplete records of committee chairs from 1984 forward, but nothing before 1984. He has a complete record of Section Chairs from 1977, but nothing earlier. Sandy will work on a method to make the information broadly available to anyone who needs it. A Section World Wide Web page probably makes sense, but perhaps it should not be the exclusive method of archiving.

This particular listserv can generate a lot of e-mail for its subscribers, and if you plan to be away from your e-mail for any period of time you may come back to a tremendous pile of mail. You should, in this case, consider having someone in the know opening and handling your mail, or unsubscribe while you are gone.

You should also note that if you choose to reply to a posting by using the reply function of your e-mail, your response will be posted to the entire population of subscribers, not just to the person posting the original message. Postings include the e-mail address of the person posting the message, and personal or individual replies should be directed to that address.

### FACULTY POSITIONS AVAILABLE

The University of Alabama School of Law seeks candidates for a tenure-track clinical law position which, depending upon demonstrated experience and ability, will be designated either Director or Associate Director of the Law School's Clinical Program. The individual's background and qualifications also will determine her or his initial academic rank.

Minimum qualifications include a J.D. degree from an ABA-accredited law school, a distinguished academic record and experience as a clinical lawyer at an ABA-accredited law school or substantial practice experience.
