STUDENT LOAN REPAYMENT

The highly touted Air Force JAG Corps Student Loan Repayment Program pays eligible JAGs up to **\$65,000** toward student loan debt. Payments are made directly to a qualified lender over a three-year period, starting after completion of the first year of service as a JAG Officer. Eligible loans can include educational loans taken out for law school, undergraduate school and graduate programs.

JAG CONTINUATION PAY

If you stay with the Air Force JAG Corps after you complete your initial four-year obligation, you can qualify for **\$60,000** in cash bonuses. The money is provided directly to you for your personal use, (e.g. loans, car, house, investments, etc).

Here's how it works: at the four-year point, sign up for another two years and you receive \$20,000; then at the six-year point, sign up for four more years and receive another \$40,000.

FULL SPECTRUM BENEFITS

The compensation JAGs receive is highly competitive. Pay raises are automatic with increased time in service and with each promotion you earn — and more than 20 percent of total monthly income is tax free.

As a JAG, you would also enjoy these outstanding benefits:

- ✓ Tax-free housing and food allowances
- ✓ 30 days of vacation with pay each year
- ✓ Comprehensive medical and dental care for you and your family
- ✓ Generous non-contributory retirement plan after 20 years of qualified service

- ✓ Eligibility for low-cost, VA-backed mortgage loans

BAR DUES REIMBURSEMENT

Air Force JAGs are eligible for reimbursement up to \$350 per year for the cost of bar membership.

TUITION ASSISTANCE

JAGs can apply for tuition assistance to help with the expense of an LL.M. obtained during off-duty hours, including online, distance and evening programs.

MASTER OF LAWS (LL.M.) PROGRAM

Every year, several JAGs are offered the opportunity to return to law school as full-time graduate students. While they focus on their studies, they receive full pay, and the Air Force pays any tuition. LL.M. Program graduates are assigned to positions where they can put their newly acquired skills to immediate use.
